PRESIDENT'S CORNER

2007 has been a busy year. I am sure that by now many of you are aware of the introduction of bill A4116: Certification for Zoning Officers. While we enthusiastically support this bill, there are ways to make this legislation even stronger. Since the Municipal Land Use Law gives municipalities the authority to designate its Administrative Officers (AO), which encompasses more than the zoning officer, NJAPZA is suggesting that a modification be considered which would require certification of the Administrative Officer (AO) in the municipality. The municipality could then designate who will be considered as the AO (Zoning Officer, Land Use Administrator, etc.). This recommendation provides greater flexibility for a municipality. We are suggesting that you contact the Bill's sponsors: Assemblywoman Valerie Vainieri Huttel and Assemblywoman Cruz-Perez to provide your support and input on the bill. Please contact our Education Chair Adele Lewis for a sample letter.

Continuing Education Credits

This is a reminder to all Members who hold a certificate. The continuing education requirements are as follows:

Planning Board/Zoning Board Secretary Certificates

- 15 hours of continuing education every 5 years
- Up to 5 hours of credit may be sought for administrative topics*
- At least 10 hours must be from land-use related classes, seminars, or lectures

Zoning Official Certificate

- 20 hours of continuing education every 5 years
- Up to 6 hours of credit may be sought for administrative topics*
- At least 14 hours must be from land-use related classes, seminars, or lectures

Land Use Administrator Certificate

- 30 hours of continuing education every 5 years
- Up to 10 hours of credit may be sought for administrative topics*
- At least 20 hours must be from land-use related classes, seminars, or lectures

***If you hold more than one type of Certificate, administrative hours from a single continuing education session may be credited toward the renewal of each certificate up to the administrative limit for each type of certificate.**
